WHEREAS, all members of the Governing Body have received and have familiarized themselves with, at least the minimum requirements of the Local Finance Board of the State of New Jersey, as stated aforesaid and have subscribed to the affidavit, as provided by the Local Finance Board; and

WHEREAS, failure to comply with the promulgation of the Local Finance Board of the State of New Jersey may subject the members of the local governing body to the penalty provisions of R.S. 52:27BB-52-to wit:

R.S. 52:27BB-52-"A local officer or member of a local governing body who, after a date fixed for compliance, fails or refuses to obey an order of the director (Director of Local Government Services), under the provisions of this Article,

shall be guilty of a misdemeanor and, upon conviction, may be fined not more than one thousand dollars (\$1,000.00) or imprisoned for not more than one year, or both, in addition shall forfeit his office."

"An abstention does not count toward the final tally, but it has the same effect as a no vote for ordinances based on the Town's form of government.

A recusal does not add to a quorum, and usually involves withdrawing from the entire proceeding, due to a conflict of interest (or avoiding the appearance thereof). An absence from a meeting neither adds to a quorum, nor allows a vote on a matter."

If this simplified form only adds to further questions, here is a more detailed statement by way of further explanation:

An <u>abstention</u> does not count toward the final tally, but it has the same effect as a "no" vote based on the Towns' form of government. Said another way, when a member abstains, they are in effect attending only to contribute to having a quorum. The NJ Appellate Part ruled abstentions may not be counted as "no" votes in <u>Zimmer v .Castellano</u>. However, and again due to the Town's form of government, because we have a 9-member voting board, in order for anything to pass, there must be 5 affirmative votes, and that applies whether there are 5, 6, 7, 8 or 9 members present. An "abstention vote" is actually not a vote at all--and generally focuses on the final decision.

A <u>recusal</u> does not add to a quorum. A quorum is number of members of a board required to hold a meeting or take action. A recusal usually involves withdrawing from the entire proceeding, usually for a conflict of interest (or avoiding the appearance thereof). When a member recuses, they must refrain from deliberation and voting on the matter.

If an elected member is absent from a meeting, that member neither adds to a quorum, nor votes on a matter.
